Sustainable Pittsburgh Privacy Policy Effective June 30, 2021

Protecting your private information is Sustainable Pittsburgh's priority. This Statement of Privacy applies to Sustainable Pittsburgh's website properties (ChooseLocalPGH.org, SustainablePittsburgh.org, CEOsforSustainability.org, C4SPgh.org, SPChallenge.org, EatSustainably.org, ShopSustainably.org, and SustainablePA.org), social presences (Facebook, Instagram, Twitter, and LinkedIn) and online advertising, henceforth called Website, and governs data collection and usage. Sustainable Pittsburgh is a 501(c)3 nonprofit organization with a mission to empower decision-making that builds a fundamentally equitable, resilient, healthy, and prosperous region.

By using the Websites identified above and engaging with our social media presence and digital advertising, you consent to the data practices described in this statement.

Collection of Your Personal Information

We do not collect any personal information from you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain services available on the Website. This may include signing up for one of our enewsletters, survey completion, sending us an email message, submitting your credit card or other payment information when purchasing memberships or making donations.

We will use your information for, but not limited to, communicating with you in relation to services you requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Sustainable Pittsburgh may collect and use your personal information to inform you of programs available to you from the organization.

Sharing information with third parties

Sustainable Pittsburgh will not sell, rent, or lease your personal information with third parties. On occasion Sustainable Pittsburgh works with third parties to highlight our programs. In this case, third parties are prohibited from using your personal information except to share information about these programs. They are required to maintain the confidentiality of your personal information.

Sustainable Pittsburgh may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Sustainable Pittsburgh or its websites; (b) protect and defend the rights or property of Sustainable Pittsburgh; and/or (c) act under exigent circumstances to protect the personal safety of users of Sustainable Pittsburgh, or the public.

Tracking User Behavior

Sustainable Pittsburgh may keep track of the pages our users visit within the Website. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of Sustainable Pittsburgh's programs, to maintain quality of our programs, and to provide general statistics regarding use of these website.

Children Under Thirteen

Sustainable Pittsburgh does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use the Website.
